2007-08 Budget

President Plaskon discussed the budget process taken by the district over the past few months.

Mrs. Haas, on behalf of the finance committee, highlighted how the budget met district goals and responsibilities while being fiscally prudent.

Time was allowed for questions and comments on the budget.

No members of the public commented on the budget.

Board comments on the budget highlighted:

- low cost per pupil rate
- high percentage of instructional budget
- low administrative costs
- budgeted facilities projects
- no increase in class size
- maintaining athletics and extracurricular activities
- continued implementation of 5-year curriculum and facility plans
- 3-year technology plan
- Continued transportation in accordance with district policy
- Participation in shared services
- Addition of writing center at the high school
- Enhancements to special education program

Budget Question

Local Tax Levy for Budget

Resolved, That there should be raised for General Funds \$69,073,157 for the ensuing school year (2007-08). The school district has proposed programs and services in addition to the core curriculum content standards adopted by the State Board of Education. Information on this budget and the programs and services it provides is available from your local school district.

Commissioner Cap

Approve the applications of the following commissioner cap adjustments to the 2007-08 school budget as follows:

Capital Outlay \$1,602,030 Special Education 253,902

Resolution for Capital Outlay Commissioner Cap Adjustment

Approve the following resolution pertaining to a commissioner cap adjustment for capital outlay expenditures in the 2007-08 tentative budget:

WHEREAS, the 2007-08 capital outlay budget includes the following items: instructional, medical, athletic and office equipment, maintenance and transportation vehicles and equipment, and facility projects, and

WHEREAS, the budgeted cost for these capital outlay expenses is \$2,206,390 and

WHEREAS, the original 2006-07 capital outlay budget was \$2,152,277, and

WHEREAS, the maximum eligible amount for a commissioner cap adjustment for capital outlay is \$1,602,030 for the 2007-08 school year, and

WHEREAS, the school district requires the entire amount of \$1,602,030 as a capital outlay commissioner cap adjustment in order to implement all budgeted items included in the 2007-08 capital outlay budget, and

WHEREAS, all items included in the capital outlay budget must be completed in the 2007-08 school year in order to implement the district's long range facility plan needs; meet the instructional needs of the district in order to provide a thorough and efficient education; maintain our periodic plans for equipment replacement; and

provide equipment essential to the administration of necessary school level activities

NOW THEREFORE BE IT RESOLVED, that the Board of Education approve the submission of this resolution along with the approved 2007-08 tentative budget to the Somerset County Superintendent for review and approval.

Upon call of the roll, motion carried with a unanimous vote recorded.
