REGULAR MEETING

OF THE

HILLSBOROUGH TOWNSHIP BOARD OF EDUCATION September 17, 2007

The Board of Education of Hillsborough Township in the county of Somerset, convened in public session on Monday, September 17, 2007 at 7:30 p.m. in the cafeteria of the Auten Road Intermediate School in the School District.

Correspondence

Correspondence was recognized from teachers at Amsterdam School and the Hillsborough Band Parents' Association.

The correspondence from the band parents' association was a request to permit a one-hour extension to the curfew at the stadium from 9:30 p.m. to 10:30 p.m. for the band festival competition. Mr. Venanzi reported that he informed the president of the band parents' association that there would be no problem with the request which has been honored for the last two years unless there was an objection from the board. No objection was raised.

Board Recognition/Awards

Dr. Forsthoffer welcomed the 2007/08 new teachers. Each principal introduced new building staff to the public.

Responding to the introductions, Dr. Forsthoffer added that the new staff is a talented group of individuals.

Mr. Lin extended a warm welcome to the new staff in joining the district.

New Business

Mr. Donnadio questioned if the public information officer will complete a press release highlighting the new teachers.

Dr. Forsthoffer announced that a press release was planned.

Mr. Donnadio expressed that board members need to be more accessible to the public and would like the communications committee to consider having board members voluntarily post e-mail addresses or cell phone numbers on the district website.

Mr. Rosenberg explained that while it is true that board members should be more accessible to the public, previous board discussion showed that the majority of the board did not want to post personal information. Mr. Rosenberg suggested the possibility of giving the board members a Hillsborough e-mail address, keeping it separate from personal e-mail.

Superintendent's Report

Dr. Forsthoffer expressed his feeling that the new staff will make a positive impact on the district.

He announced that Wednesday, September 19, is the official ribbon cutting ceremony for the high school's new writing center.

Dr. Forsthoffer also reminded the public that the high school band, current NJ Group 4 Champions, will be highlighted at an exhibition to be held at the Hillsborough High School field on October 13. He invited the public to come out and support the band.

Dr. Forsthoffer announced that Dr. Antunes is doing well waiting for the arrival of her baby and then noted that that this was the last board meeting for Mr. Venanzi and Mrs. Wells, recognizing contributions made to the district and wishing them well.

Dr. Forsthoffer referred to Mr. Venanzi to discuss the bond refunding.

Mr. Venanzi announced that the district was successful in negotiating a private bond refunding for approximately \$9 million in outstanding debt in accordance with all requirements of the local finance board. The district achieved the minimum amount of savings required, which was 3% net present value. Gross savings in debt service interest amounts to \$392,000 over a 14 month period, which translates to \$25,000-\$30,000 per year.

Time was allowed for questions and comments from the board and public on the superintendent's report.
