The Board of Education of Hillsborough Township in the county of Somerset, convened in public session on Monday, October 15, 2007 at 7:00 p.m. in the cafeteria of the Auten Road Intermediate School in the School District.

Superintendent's Report

Dr. Forsthoffer reported on the Violence and Vandalism report that is on this evening's agenda. This is an annual report which is mandated by the state. Its purpose is to notify the state of recent reports of violence, vandalism, and substance abuse cases for each district. He stated that although Hillsborough's numbers are remarkably low, the goal is for zero in the district. During the 2006-07 school year, Hillsborough reported 27 cases of violence, 6 vandalism, 3 weapons, and 5 cases of substance abuse. He made particular note of the weapons noting that these cases involved pen knives that were confiscated from student's backpacks and they did not involve any instance of threat.

There were no comments or questions from the public on the Violence and Vandalism report.

Dr. Forsthoffer then went on to address the Memorandum of Agreement that is also on this evening's agenda. This agreement is accepted annually and is an agreement between the district, municipality, and police department to have open communication and work together for the better of the community. He stated that the district has always had a great relationship with the police department and worked together as recently as last week utilizing the instant alert system to notify families of a suspicious incident.

He stated that the annual financial audit is also on this evening's agenda and asked Mr. Gillette, finance committee chairperson to elaborate.

Mr. Gillette reported that the finance committee met with Mr. Vrabel, district auditor, to go over the findings of the Comprehensive Annual Financial Report (CAFR), prior to this evenings meeting. He was pleased to announce that there are no recommendations and that the district is in full compliance with general accounting principals.

In closing, Dr. Forsthoffer mentioned that the district is currently working on filling administrative vacancies, particularly the position of business administrator and his/her assistant. He noted that he is recommending a candidate for approval for the position of district math supervisor on this evening's agenda. He also reported that interviews are well underway for the Woods Road School principal position and he is preparing to meet with the finalists.
