Board Recognition

Dr. Antunes recognized the Mock Trial team who went undefeated in the county tournament, to win its third county championship. She then introduced Mr. Fenster, advisor, who presented the nine student team members. Mr. Fenster requested that the board and administration consider banners to recognize academic teams, similar to those hanging in the school for athletic teams.

Mr. Fenster then introduced the 14 Debate Team members. The team won the Best Large Delegation award at the Philadelphia Model United Nations conference in February. Mr. Fenster also announced the six individual team winners. The team will be attending the Rutgers Model Congress in April.

Dr. Antunes recognized the high school Robotics team who recently won the Autodesk Animation Award at the NJ Regional. The team also earned the Chairman's Award which was awarded by F.I.R.S.T. (For Inspiration and Recognition of Science and Technology). This award qualifies the team for the Championship competition in Atlanta in April. This past weekend, the team also competed in a regional competition in Annapolis, Maryland. They won the robotics competition as well as the "GM Industrial Design Award." This award allows the team an opportunity to publish the design process in a book. Mr. Chernoff, robotics advisor, recognized the 65 student team members.

Resolution Establishing Annual School Threshold for Business Travel

Approve the following resolution establishing an annual school threshold for district business travel:

WHEREAS, the Hillsborough Board of Education recognizes school staff and Board members will incur travel expenses related to and within the scope of their current responsibilities and for travel that promotes the delivery of instruction or furthers the efficient operation of the school district; and

WHEREAS, N.J.A.C. 6A:23B-1.1 et seq. requires Board members to receive prior approval of these expenses by a majority of the full voting membership of the Board and staff members to receive prior approval of these expenses by the Superintendent of Schools and a majority of the full voting membership of the Board; and

WHEREAS, a Board of Education may establish, for regular district business travel only as described in NJOMB Circular Letter 06-02, including amendments or revisions thereto, a threshold amount below which Board approval is not required; and

WHEREAS, the Board of Education establishes, for regular district business travel only, an annual school year threshold of \$4,200 per staff/Board member where prior Board approval shall not be required unless this annual threshold for a staff/Board member is exceeded in a given school year (July 1 through June 30); and

WHEREAS, travel and related expenses not in compliance with N.J.A.C. 6A:23B-1.1 et seq., but deemed by the Board of Education to be necessary and unavoidable are excluded from the requirements of N.J.A.C. 6A:23B-1.1 et seq.;

THEREFORE, BE IT RESOLVED, the Board of Education approves all travel not in compliance with N.J.A.C. 6A:23B-1.1 et seq. as being necessary and unavoidable up to \$4,200 per year.

Old Business

Mr. Schneider discussed the issue of our districts substitute pay. He thanked Dr. Lake for researching other districts and pointed out that comparatively, Hillsborough falls somewhere in the middle. Mr. Schneider requested that the district research substitute pay in more detail prior to finalizing the budget. Issues to consider are: paying different amounts for certificated substitutes vs. noncertificated and paying long-term substitutes more to keep them indistrict and provide greater continuity for the students. Mr. Sloan stated that the recommendation of the finance committee was to not make any changes in substitute pay this year in light of budgetary constraints and a desire to keep taxes lower.

President Plaskon asked Mr. Schneider to work with one or two other board members to present a proposal to the board on substitute pay.

Mr. Sloan agreed to work on the committee with Mr. Schneider.

President Plaskon announced that a special meeting will be held on Monday, March 26, in the Auten Road School Cafeteria at 7:30 p.m. to finalize the 2007/08 budget. The preliminary budget was sent and approved by the County Superintendent. The board will be approving the final budget at the March 26 meeting for public vote on Tuesday, April 17.
