Dr. Lake closed her final report with a paragraph from the message she sent to the community when she first came into the district:

"It is my strong opinion that an organization is as good as the people it employs. In essence, you are the lifeblood of the Hillsborough School District. However, our district exists for its students. Our students, who are our future, give us the opportunity to band together despite our differences and find commonality in an united effort which is to serve the children of the community. For this opportunity, we are fortunate and look to the future with confidence knowing our children will be provided with a quality education so necessary for them to meet the challenges of this millennium."

Diana Dorsey, resident and parent of a Sunnymead student, questioned the size of next years $4^{\rm th}$ grade classes at Sunnymead Elementary School.

Dr. Lake discussed differences in standards for the grade levels, but stated that as of this date, projections indicate that no class will contain over 23 students. The district maximum is set at 25.

Mr. Detsis, resident and parent of a high school student, questioned the summer reading assignment on Global Warming. Mr. Detsis felt the required reading book by Al Gore was political and should not be in our public schools.

Mr. Schneider, curriculum committee chairperson, explained that in choosing the book, the committee never saw it as political. He stated that the book will initiate discussion and the students have the opportunity to critique the book.

WHEREAS, the Hillsborough Township Board of Education (hereinafter referred to as the "Board") and Lisa M. Antunes (hereinafter referred to as "Antunes') are parties to an Employment Agreement for the period beginning July 1, 2007, and ending June 30, 2008, wherein Antunes shall serve as Assistant Superintendent for Curriculum and Instruction (hereinafter referred to as the "Employment Agreement"); and

WHEREAS, the Superintendent of Schools is resigning her position for the purpose of retirement, thereby creating a vacancy in the position of Superintendent of Schools, effective June 30, 2007; and

WHEREAS, the Board is desirous of appointing Antunes to perform the duties of Interim Superintendent of Schools until the Board appoints a permanent Superintendent of Schools to fill the vacancy; and

WHEREAS, the responsibilities of the Interim Superintendent of Schools shall include serving as the chief executive and administrative officer of the Board and shall have general supervision over all aspects, including the fiscal operations and instructional programs of

the Hillsborough Township School District (hereinafter referred to as the "District"), and shall arrange the administrative and supervisory staff, including instruction and business affairs in a manner which, in her judgment, best serves the District. The Interim Superintendent of Schools shall also be responsible for the selection, placement, transfer, renewal and dismissal of personnel, both instructional and non-instructional, subject to board approval, as more particularly set forth in Board Policy Nos. 1220 and 1230.

WHEREAS, Antunes is desirous of accepting the Board's appointment to the position of Interim Superintendent of Schools; and

NOW THEREFORE, based on the foregoing premises and mutual promises and covenants contained herein, the parties hereby agree that:

- 1. Antunes shall be appointed Interim Superintendent of Schools.
- 2. Antunes' duties as Interim Superintendent of Schools shall commence on July 1, 2007, and end with the Board's appointment of a permanent Superintendent of Schools to fill the vacancy, at which time Antunes' duties as Interim Superintendent of Schools shall terminate and Antunes shall continue her duties as Assistant Superintendent for Curriculum and Instruction.
- 3. If the certification of the Interim Superintendent is revoked the Employment Agreement shall be null and void as of the date of the revocation.
