#### D. Food Services Agreement

Approve the first year renewal contract/agreement for Food Service Program Management Services for the 2010-11 school year with Sodexo Management, Inc.

**Management Fee**: The District shall pay Sodexo a Management Fee in an amount equal to Fourteen and One Half Cents (\$.145) per Pattern Meal for the 2010-2011 contract year. The Management Fee shall be calculated at the end of each Accounting Period during the school year and prorated for any partial Accounting Period. Partial Accounting Period shall be defined as a period of time less than one (1) month.

**Surplus Guarantee**: Sodexo guarantees that District shall receive an annual financial return of One Hundred Twelve Thousand Dollars (\$112,000.00) for the 2010-2011 school year. If the annual financial return for the Food Service program falls short of the aforementioned amount, Sodexo shall pay the difference to District in an amount not to exceed one hundred percent (100%) of Sodexo's annual Management Fee Sodexo reserves the right to recover any such reimbursement made during the current contract year from that year's Surplus on a monthly basis.
