REGULAR MEETING

OF THE

HILLSBOROUGH TOWNSHIP BOARD OF EDUCATION December 17, 2007

The Board of Education of Hillsborough Township in the county of Somerset, convened in public session on Monday, December 17, 2007 at 6:30 p.m. in the cafeteria of the Auten Road Intermediate School in the School District.

Board Recognition/Awards

Dr. Forsthoffer introduced Mr. Ray Fantuzzi, band parent volunteer, who spoke about the many accomplishments and numerous awards received by the Hillsborough High School Marching Band. He thanked all of the parents for their support and introduced Mrs. Linda Mackiw, Band Parent Association President.

Mr. Fantuzzi stated that the marching band, comprised of 93 students, recently participated in a national competition held at the Raven's Football Stadium in Baltimore, Maryland, and placed 3rd nationally. A video presentation of the band's performance at that competition was then shown.

Dr Forsthoffer congratulated Mrs. Julia Haran, band director, Mr. Fantuzzi, and all of the student's and their families on their many accomplishments.

New Business

Mr. Michael Detsis thanked the district for their efforts in improving communications with the high school and said that he has noticed a vast

improvement. He then questioned whether board meetings can be made available for viewing "on demand" on the district website.

Dr. Forsthoffer stated that he will check with the technology director, Mr. Joel Handler, on the possibility of doing so and report on his findings at a later date.

Superintendent's Report

Dr. Forsthoffer spoke briefly about the development of the district goals, which the board worked on developing at a special meeting held on November 1.

He stated that traditionally the district goals and objectives are developed earlier; however, with his recent arrival, it was decided to hold off on their development so that he could participate. He has prepared a one page summary of the goals that have been identified. He expects by May that the district will develop a strategic plan and map out the philosophy of the school district and direction to move in over the next five years.

Dr. Forsthoffer then introduced Mrs. Leonore Johnston, director of special services, to speak about the goals and development Camp HEART, a shared services program that runs during the summer for students with special needs.

Mrs. Johnston stated that last year, she had worked closely with Mr. Richard Resavy, Hillsborough Township Recreation Director, in the development of Camp Heart, identifying goals with the assistance of parent surveys. She stated that they have achieved most of the goals and are continuing to develop additional goals as identified.

Mrs. Johnston outlined a typical day of a child participating in the program and identified 3 major objectives that they continue to work on as outlined below:

- Continue to decrease the number of transitions students experience during the recreation component of the day.
- Provide age-appropriate activities for middle school and high schoolaged students.
- · Provide inclusive setting with typical peers

Mrs. Johnston closed by stating that she looks forward to the continued growth and success of Camp HEART.

Time was allowed for questions and comments from the board and public on the superintendent's report.

Mr. Paget commented on a request by parents to have information on the program disseminated in a more timely fashion.

Mrs. Johnston responded by stating that parents are advised at their child's individual IEP meetings which take place throughout the year.

Mr. Lin questioned whether last year's goals were based on an assessment of the prior year and whether the goals for the upcoming year were based on the results of that assessment.

Mr. Lin also commented on the analysis of the suspension report for the month of November noting two spikes in the area of failure to serve detention and theft and asked if this spike was typical of this time of year.

Dr. Forsthoffer responded that although the numbers have increased, it is not atypical. In relation to the suspensions related to theft, he attributes that to better diligence on the part of the staff in identifying students who are stealing, particularly in the area of small food items in the cafeteria.

Mr. Lin stated that he would like to see an analysis done of last years suspensions to see if this in fact a trend or an anomaly.

Old Business

Mrs. Lorrain Soisson spoke on the appointment of Mrs. Lisa Heisel as principal of Triangle School. She thanked the administration for the opportunity to serve on the selection committee and noted that it was a

very smooth and transparent process. She congratulated Mrs. Heisel on her appointment.

Mr. Detsis questioned a line item transfer related to middle school drug testing and requested clarification on what this was for.

Dr. Forsthoffer explained that this cost was related to a middle school student who was suspected of being under the influence. He noted that this cost was extraordinary due to special circumstances. District policy dictates that a student must be tested within two hours of being suspected. Because the parents were unavailable to transport their child for testing, the local rescue squad was dispatched to transport this student to the hospital emergency room for evaluation, causing the additional costs. Dr. Forsthoffer is working with the police department and rescue squad to stream line the process in order to prevent such costs.

Announcements by the President

President Hudes noted that at the last board meeting, there was discussion of changing the date of the January work meeting. After polling the board, it was decided that the meeting would be changed from January 14 to January 3. The main topic of discussion at that meeting will be the public hearing on the proposed random drug testing policy.

He closed the meeting by wishing everyone a safe and happy holiday.
